What is IRAP?

The Infosec Registered Assessors Program (IRAP), governed by the Australian Signals Directorate (ASD) provides a framework for assessing the security of cloud systems used by the Australian Government.

- Decentralized & Flexible: IRAP is not a centrally managed authorization program no sponsor is required, registered IRAP Assessors perform assessments, consumer agencies review results, and there is no centralized marketplace of assessed products.
- Independent Assessments: Registered IRAP Assessors evaluate systems but do not certify, accredit, or endorse them; risk decisions are made by the consumer agency.
- Risk-Based Evaluation: IRAP focuses on how the Information Security Manual (ISM) is implemented and the residual risk to customer data, allowing agencies to make informed decisions based on their own risk tolerance.

Assessment

An IRAP Assessor performs an in-depth evaluation of your security controls—including documentation review, evidence collection, and stakeholder interviews—culminating in a formal IRAP Assessment Report that outlines implementation status and residual risks to demonstrate alignment with ISM requirements.



Post-assessment, we assist in maintaining up-to-date documentation and security controls to stay aligned with quarterly ISM updates and any changes imposed by the ASD.
